Author John Hayes is the only person, so far, who has said something so spot on about the whole franchising business: it all boils down to asking a lot of questions. And indeed, his book, '101 Questions to Ask before you Invest in a Franchise' consists of ALL the helpful questions you need to ask yourself (and your prospective business partners/franchisor) to make sure you're actually making the right decision. Even now, despite the experience of many people, franchising still has that 'halo' of being 'easy'. Many people choose the franchising route when they're engaging in business for the first time, fully believing that it's a more "proven" way to succeed in business. After all, you're franchising an already proven brand name, right? As it turns out, the real hard answers are not written in black and white. While franchising can be relatively easy, it's really not for everyone. And if you've already issued that check to that salesman, then it's probably too late to ask the right questions. But for those who are still trying to decide whether or not to enter the franchising business, Hayes's book will at least lead you to the right direction.
